NOTIFICATION UNDER ARTICLE 12.1(B) OF THE AGREEMENT ON SAFEGUARDS ON FINDING A SERIOUS INJURY OR THREAT THEREOF CAUSED BY INCREASED IMPORTS

PROPOSAL TO EXTEND A MEASURE

NOTIFICATION PURSUANT TO ARTICLE 9, FOOTNOTE 2 OF THE AGREEMENT ON SAFEGUARDS

JORDAN

(Aluminium Bars, Rods and Profiles)

Supplement

The following communication, dated 13 September 2019, is being circulated at the request of the delegation of Jordan.

In accordance with Article 12.1(b) of the Agreement on Safeguards, Jordan hereby submits its notification of a proposal to extend of the safeguard measure on imports of Aluminium bars, rods and profiles.

1. Provide a precise description of the product involved

Products involved are those under the following Jordanian tariff headings: (7604) except which is imported as a production inputs under subheadings (7604.211, 7604.101, 7604.212, 7604.291).

2. Provide a precise description of the final measure

Imposing in addition to the applied tariff duty, a specific surcharge of JD 290 per Ton, subject to annual liberalization of JD 10 per Ton.

3. Provide date of introduction of the measure

In accordance with Article 25 of the "Regulation on Safeguards of National Production No.55 for the year 2000", the date of introduction of the measure is the date of publishing the decision of the Council of Ministers to impose the safeguard measure in two daily local newspapers. The date of introduction of the measure shall be notified to the committee on safeguards once the decision is published in the two daily local newspapers

4. Provide the expected duration of the measure

NPPD plans to extend the safeguard measure for an additional three years.

5. If the expected duration is over one year, provide the expected timetable for progressive liberalization of the measure

The measure is proposed to be liberalized as stated in the point related to the **precise** description of the final measure.

6. If the measure is being extended, also provide:

(i) Evidence that the industry concerned is adjusting and that the safeguard measure continues to be necessary to prevent or remedy serious injury;

The Aluminum bars, rods and profiles domestic industry has provided evidence showing that it has instituted a structural adjustment plan aimed at increasing its competitiveness, and carried out portions of its adjustment plan.

In light of the above-mentioned evidence, NPPD concludes that the extension of the safeguard measure continues to be necessary to remedy or prevent serious injury to the Aluminium bars, rods and profiles domestic industry, which is making adjustments to improve its competitiveness.

In order to determine whether the safeguard measure continues to be necessary to remedy Serious injury, the NPPD examined the imports which shows increase in 2018 compared with 2017 also the domestic industry's economic indicators, namely production, domestic sales, capacity utilization, Stocks, employment, Gross Profit, productivity, Market share. , on which it has revealed a decline in economic indicators.

Consistent with Article 12.3 of the Agreement on Safeguards, Jordan is prepared to consult on the proposed safeguard measure with those members having a substantial interest of the subject product.

Members intending to consult shall inform the NPPD within 5 days from the date of publication of the notification on the WTO website.
