The following communication, dated 29 May 2020, is being circulated at the request of the delegation of Indonesia.

Pursuant to Articles 12.1(c) of the WTO Agreement on Safeguards, the Government of the Republic of Indonesia hereby notifies the issuance of Minister of Finance's Regulation Number 55/PMK.010/2020 dated 27 May 2020, promulgated in the Official Gazette of the Republic of Indonesia Number 526-2020 on 27 May 2020 regarding the imposition of a safeguard measure on the importation of Fabrics, for 3 periods started on 27 May 2020.

**A. GENERAL BACKGROUND**

On 3 March 2020, the Republic of Indonesia notified the findings of safeguard investigation in which it was concluded that there was an evidence that the increased of volume of imports have caused a serious injury to the domestic industry concerned in this investigation (G/SG/N/8/IDN/23 - G/SG/N/10/IDN/23).

It was also indicated in the notification that the Investigating Authority was proposing to the Government of the Republic of Indonesia the imposition of a safeguard measure on the importation of the subject goods.
